## 2009 EXHIBITOR'S CONTRACT

1. Your location within the exhibit area will be decided by Victory Productions of Valley Forge, LLC ("VPVF"). You will occupy only the licensed area and conduct your business at your own risk and in a businesslike manner in accordance with all state, local and other laws. Any violation of this promise will result in ejection from the Show at the sole discretion of VPVF with no refund and no liability on the part of VPVF.
2. Exhibitor shall not assign any portion of its booth space to any individual, partnership, corporation, company, firm or entity, without the prior written consent of the Show. No Exhibitor shall assign, sublet or apportion the whole or any part of the space allotted to it. Nor shall any Exhibitor display any other goods, apparatus, material or service that is not manufactured or distributed by the Exhibitor in the regular course of its business or allow any other person or party to do so.
3. Payment in full for Exhibitor's booth space shall accompany this signed Exhibitor's Agreement and must be received to hold your booth space reservation.
4. Hours of Show are Friday, 4:00 pm – 9:00 pm; Saturday, 10:00 am – 6:00 pm and Sunday, 10:00 am – 5:00 pm. Exhibitor shall have exhibit(s) completely assembled and ready to be viewed by guests no later than 3:00 pm on Friday, March 6, 2009. Exhibitor shall not begin disassembling its exhibit(s) until 5:00 pm Sunday, March 8, 2009.
5. Overnight security will be provided from Show close to 8:00 am the days of the Show. While security is provided, the Show shall not be responsible for any losses Exhibitor might suffer.
6. Exhibitor acknowledges VPVF and the Show does not have insurance covering Exhibitor's property. It is Exhibitor's sole responsibility to obtain interruption, property damage, personal injury, vandalism, theft and any other insurance it might need to cover any losses it might suffer at the Show.
7. Neither VPVF nor Valley Forge Convention Center shall be responsible in the event that the Show is cancelled or shortened or the dates changed due to inclement weather, acts of God or nature, acts of war or any other reason whatsoever. **NO REFUNDS OR CREDITS WILL BE GIVEN.**
8. If Exhibitor is not able to attend the Show, Exhibitor may be entitled to a refund on the following schedule:
  - **60 day:** If written cancellation is received January 6, 2009, and if booth space is resold, Exhibitor is entitled to an 80% refund.
  - **30 day:** If written cancellation is received by February 6, 2009, and if booth space is resold, Exhibitor is entitled to a 50% refund.
  - **Less than 30 days:** If Exhibitor cancels after February 6, 2009, Exhibitor will not receive a refund.
9. Excessive noise, bothersome lighting or other use by Exhibitor that interferes with the exhibition space used by Exhibitors is prohibited, as is the creation or maintenance by Exhibitor of any dangerous or hazardous condition or situation. The aisles belong to the Show. Neither Exhibitor nor advertising material shall protrude into the aisles. Booth shall not exceed 8 feet in height without Show Coordinator's approval.

10. The Show does not provide equipment, decoration, labor carpenters, storage for exhibit materials, special lighting, gas, water supply or other related services. All arrangement for these items must be made by Exhibitor and Exhibitor shall defend, indemnify and hold harmless the Show for any and all claims, losses, damages, injuries or other charges that might occur from such arrangements made by Exhibitor.
11. Exhibitor will receive two (2) badges per 10' x 10' booth for staff to work their exhibit. Please see Booth Price Chart below for number of badges provided per booth size. Additional badges can be obtained at a cost of \$10.00 per badge.
12. Exhibitor shall and does agree to indemnify, defend and hold VPVF and Valley Forge Convention Center, their successors and assigns harmless for any and all liability damage to property or injury to persons resulting from or arising out of the operation of the Exhibitor's business or booth pursuant to this agreement including the setting up and dismantling of the exhibits.
13. Exhibitors having demonstrations or activities involving club swinging within the confines of their booth or any other potentially dangerous situation, will be required to maintain liability insurance having general aggregate limits of not less than \$1,000,000 and naming Victory Productions of Valley Forge, LLC and the Show facility (Valley Forge Convention Center) as additional insured during the term of the Agreement. A valid certificate of insurance evidencing such coverage must be provided to Management thirty (30) days prior to the start of the Show.
14. This agreement may be terminated at the option of VPVF in its sole and absolute discretion without notice to Exhibitor upon the breach by Exhibitor of any or all of the terms and conditions contained herein, with no liability to Exhibitor.
15. Exhibitor agrees to abide by this contract and completely understands and agrees to abide by the attached rules and regulations.
